



Only a report that has not been filed (submitted) can be edited or revised to accept any corrections or new sales information in the SIT Portal. If a monthly report has already been filed, then the dealer must file a supplemental statement to revise the sales for that month by mail.

Monthly Sales Entry

1. If the month has a ✓ (check mark), then the monthly statement has been filed, and online revision is not allowed.
2. "Action" column:
 "edit" - allow revision to the monthly report.
 "view" - the monthly report has been closed and cannot be revised online.
3. Click to select the month corresponding to the month of the dealer's sales. The sales page will appear.

Sales Page

This page allows the user to:

1. Create new individual sales record.

Enter Sales

Create the new sales record by entering:

1. Date of sale
2. Year of the vehicle
3. Make of vehicle
4. VIN or serial ID number
5. Buyer's name
6. Sale type – click drop arrow to select type
7. Price of sale

Note: the tax amount will be automatically calculated from the sales price.

Select:

8. Add Another to save entry and continue to next entry, or
8. Cancel to exit without saving information, or
8. Finish to save and exit

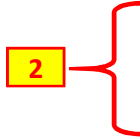
