<b>Application for title</b> (Required for transfer of ownership, registering lien, etc.) .....	\$ 33.00
<b>Transfer registration fee</b> (If vehicle is currently registered) .....	\$ 2.50
<b>Inspection fees</b> .....	<a href="http://twostepsonesticker.com/motorists">http://twostepsonesticker.com/motorists</a>
<b>Penalty for late filing or title transfer</b> .....	\$ 25.00 *

\* Effective 1/1/12, late filing fees for title transfers from one individual to another are calculated as follows:

- \$25 late transfer penalty if buyer applies for the transfer between 31 calendar days and 61 calendar days after date of sale.
- Military Personnel have up to 60 calendar days to transfer before a late penalty is assessed.
- ADD an additional \$25 penalty for each additional 30 calendar-day period. Maximum \$250.00
- Dealers: \$10.00 delinquent transfer penalty if the vehicle was submitted after the 30th day regardless of the expiration date of the registration.
- The late transfer fee will apply to any transfer of title for the following title types of ownership documents: MCO, Out of State Title, Original Texas Title, Certified Copy of Certificate of Texas Title, Form 97, Government Bill of Sale, Auction Sales Receipt, Bonded Titles, Court Orders, Title Hearings, Storage Lien

### Sales Tax on Vehicles

If paid within 30 calendar days of date of purchase . . . . . 6.25% of purchase price or Standard Presumptive Value (SPV), whichever is higher.

#### Penalties for Late Payment of Sales Tax

If paid 1 to 30 calendar days late .....	5% of sales tax
If paid more than 30 calendar days late .....	10% of sales tax
