## 2014-2015 Property Tax Calendar

| January 1,<br>2015  | Harris County Appraisal District (HCAD) determines appraised value and exemption status for property taxes for the 2015 tax year, with the exception of disability and over-65 exemptions.  |
|---------------------|---|
| February 2,<br>2015 | Since January 31 <sup>st</sup> falls on a Saturday, the regular deadline for 2015 is extended to the next business day of February 2 <sup>nd</sup> .  |
|                     | This is the last day to pay 2014 property taxes without incurring delinquent penalty and interest.  |
|                     | This also is the last date to notify our office in writing to request a quarter payment plan and make the first payment <b>without incurring late fees.</b>   |
|                     | The quarter payment plan is for accounts with an over-65, disability homestead exemption, or qualified disabled veteran or surviving spouse exemption.  |
| February 3,<br>2015 | Penalty and interest charges begin to accrue on unpaid taxes for the 2014 tax year. The combined penalty and interest rates rate begin at 7% on February 3rd and increases each month that the payment remains unpaid, capping at 18% in July.              |
|                     | Taxpayers can enter into installment agreements on current tax year (2014)<br>delinquent taxes only for non-homestead residential property and for any<br>delinquent tax year on residential homestead property.  |
| March 2,<br>2015    | Since February 28th falls on a Saturday, the regular deadline for 2015 is extended to the next business day of March 2 <sup>nd</sup> .  |
|                     | This is the final day to notify our office in writing to request a quarter payment plan and make the first payment. However a late fee will be incurred.  |
|                     | The quarter payment plan is for accounts with an over-65, disability homestead exemption, or qualified disabled veteran or surviving spouse exemption.  |
| March 31,<br>2015   | This is the last day to make the second payment on quarter payment plans<br>for accounts with over-65 and disability homestead exemption, or qualified<br>disabled veteran or surviving spouse exemption. Payment after this date<br>will incur a late fee. |

| April 3,<br>2015    | This is the last day to pay business personal property accounts that received section 33.11 notices before the accounts are turned over to the delinquent collection attorneys.  |
|---------------------|--|
| April 4,<br>2015    | The Harris County Tax Office turns over for collection all delinquent<br>business personal property accounts on this date. Immediately, a collection<br>penalty of 15% - 20% of the total unpaid balance is added to the current<br>delinquent account.    |
| June 1,<br>2015     | This is the last day to make the third payment on quarter payment plans for<br>accounts with over-65 and disability homestead exemption, or qualified<br>disabled veteran or surviving spouse exemption. Payment after this date<br>will incur a late fee. |
|                     | This is also the last day to file a notice of protest with the Harris County<br>Appraisal District for the 2015 tax year.  |
| June 30,<br>2015    | This is the last day to enter into an installment agreement with the Harris<br>County Tax Assessor-Collector's Office to pay the current tax year's<br>delinquent taxes for non-homestead residential accounts.  |
| July 1,<br>2015     | The Harris County Tax Office turns over for collection all delinquent real property accounts on this date. A collection penalty of 15%-20% of the total unpaid balance is also added to the current tax year delinquent account.                           |
| July 31,<br>2015    | This is the last day to make the final payment on quarter payment plans for<br>accounts with over-65 and disability homestead exemption, or qualified<br>disabled veteran or surviving spouse exemption. Payment after this date<br>will incur a late fee. |
| August 31,<br>2015  | The last day to file a name and/or address change with HCAD in order for the changes to be shown on the original tax roll for the 2015 billing year.   |
| October<br>2015     | The 2015 tax year begins: Certification of property values, adoption of tax rates, Truth-in-Taxation, and property tax assessment.   |
| October 17,<br>2015 | Last day to sign up for a 2015 e-Bill with the Harris County Tax Assessor-<br>Collector's Office.  |

| November<br>2015     | The Harris County Tax Assessor-Collector's Office begins delivering the 2015 tax bills to real and business personal property owners and agents.  |
|----------------------|---|
| December<br>31, 2015 | Last day to make property tax payment for federal income tax deduction<br>purposes. Payments must be sent in time to receive a December postmark<br>or receipt date by a third party carrier or, if made online or via the<br>telephone, the transaction must be completed before midnight, Central<br>Standard time. |
